

Request for Haywood Community College Course Eligibility Determination

I wish to be considered for one or more Haywood Community College (HCC) classes for next year. Upon submitting this request, my Tuscola High School (THS) Counselor will look at my weighted GPA and any available test scores to see if I meet the requirement for HCC classes. Once that is determined, I will be notified VIA the REMIND app as to my eligibility. If I am eligible, I will be given an HCC application and the application will be due on Friday, March 9. If I am not eligible, I will have the opportunity to come in and further discuss my options with the HCC High School Program Coordinator and my THS counselor.

If eligible, should I decide to enroll in one or more college courses, I am aware of the following:

_____ _____ I realize that if I sign up for an online class that I MUST physically sit in THS room D10 every day during the period that my online class is scheduled. I am not allowed to leave campus or sit anywhere else on campus as I am assigned to room D10 and attendance is taken. I will have 85 minutes per class period to complete work, but it is recommended that I have online access at home, or the ability to visit the library or other public space on a regular basis if I need to work on my HCC assignments

_____ _____ I realize that if I enroll in a course taught on HCC's campus (face-to-face) I am responsible for my own transportation. Relying on a friend or other student is not recommended.

_____ _____ Face-to-face classes do not typically meet everyday, but rather a Monday, Wednesday, Friday (MWF) schedule or a Tuesday, Thursday (TR) schedule. On the day(s) that my face-to-face class does not meet, I will report to a specified location or I will not be on the THS campus.

_____ _____ I realize that when my test scores are checked and that is what makes me ineligible, it is my responsibility to schedule a time to go to HCC and complete one or more portions of the NCDAP in order to continue the process of eligibility.

_____ _____ I realize that the HCC and Haywood County Schools schedules do not match identically. There may be times That I will be required to work on HCC coursework when HCS is not in session.

_____ _____ **I realize that if after Day 10 of my THS semester, whether I choose to withdraw from my HCC course (penalty or no at HCC), or whether I am withdrawn from the class by my instructor due to attendance or other issues, that I WILL RECEIVE AN F (55) ON MY HIGH SCHOOL TRANSCRIPT FOR THIS COURSE.** After Day 10, THS nor HCC has the ability to enroll me in any other course, so I will receive an F.
