

Together we have been on quite a roller coaster ride. COVID-19 has changed our lives forever. We, as individuals, as a school system, as a community, and even as a world, have endured so many changes that it is hard to comprehend. One thing we can be proud of is that we have withstood these changes and continued to put our students first.

Our community is nothing short of amazing. Your continued support has aided the students, employees, and schools of Haywood County Consolidated Schools to remain steadfast in our mission.

We have been able to fund 94 high school senior scholarships and more than 130 employee grants. The HCSF funded district-wide staff development about unconscious bias with 100 percent attendance by school board members, principals, assistant principals, and teacher leader teams from each school/department site.

COVID certainly did not let up, and the Foundation was able to provide some relief in many forms to our students, schools, and employees. More than \$29,000 was spent to ease the strain of the pandemic.

Moving into a new and brighter year, the mission of the Haywood County Schools Foundation continues to guide all of our decisions, goals, and practices. We are committed to providing educational opportunities for our students, schools, and employees. On behalf of the staff and board of directors, I want to thank you for your support. As we embark on the 2021-22 school year, please remember we are truly all in this together.

Welcome to Haywood County Schools for the 2021-22 school year. Like much of North Carolina and the rest of the nation, we have experienced a very difficult year and a half. COVID-19 and significant civil unrest created volatile and unpredictable times. When COVID-19 hit, we made a conscious decision to do as much as we could for the community, our students, and our staff.

In-person learning was shut down by the state on Saturday, March 14, 2020. By Tuesday, March 17, 2020 we had provided over 2,200 meals to the community, distributed hundreds of educational activities in paper and digital form, loaned students 948 Chromebooks (and other devices) and provided many reassuring messages to our students and families. By the end of the summer, we had distributed over three-quarter of a million meals to the community. When in-person learning was allowed to resume by the state, we opened our doors five days a week while most schools in the state only opened four days a week. Twenty-five school systems didn't open for in-person learning for over a year.

Our teachers, staff members, administrators and board members are awesome. Our community is awesome too. Many community organizations and individuals rallied to provide support for our families, our community, and our schools.

We will open the 2021-22 school year with all in-person learning. The last year and a half taught us that remote learning only works well for a small percentage of students. We were very successful preventing the on-campus spread of COVID-19. We will work to do the same in 2021-22.

Unfortunately, society seems to be growing more divided. In the past, I encouraged people to foster unity and to be less divisive while often using the tag-line, "be kind, be smart, and be safe." I implemented an administrative regulation designed to make school campuses and our public events less divisive. This summer, we worked on a policy amendment designed to guide employees in supporting unity and kindness by avoiding the promotion of particular concepts or resources related to race, sex or personal, political, social or religious beliefs.

Thankfully, the vast majority of our employees are kind, capable and supportive people. Like most policy amendments, this was written for a few who might use their position to promote their personal beliefs with students. For students, school should be about learning and having opportunities to participate in academic and extra-curricular activities. Our students should be our common focus.

We rallied to support our students during COVID-19. Let's work to ensure they have a learning environment that is free from criticism of their race, sex or personal, political, social or religious beliefs. Be kind, be smart, and be safe. The policy (7305) amendment reads as follows:

Many classes include lessons on history, civics, politics and current events. During these lessons, students are a captive audience and teachers should focus on the state and local curriculum standards and critical thinking skills. Teachers should not focus on their own personal beliefs or those of their students. Further, students and employees, should be able to attend school and school-related activities free from overt criticism, alienation or retaliation for their personal, political, social or religious beliefs. Assignments and materials shall be used in contexts that make it clear that Haywood County Schools does not sponsor or promote particular concepts or resources related to race, sex or personal, political, social or religious beliefs.

All instructional activities shall focus on state or locally approved curriculum standards in assigned courses or classes that are ageappropriate and should not be used to influence or inculcate students with a particular belief. School employees shall not use their position to promote or impose their own personal, political, social or religious beliefs on students. School employees shall not criticize, humiliate, embarrass or discredit students for their race, sex or personal, political, social or religious beliefs.

Nothing in this section shall be construed as prohibiting (1) speech protected by the First Amendment of the U.S. Constitution and (2) accessing materials on an individual basis for the purpose of research or independent study.


# HOW WE MAKE A DIFFERENCE






# PARTNERS IN EDUCATION

In May, the Haywood County Schools Foundation awarded 94 Pisgah, Tuscola, Haywood Early College, and Central Haywood high school seniors with 119 scholarships totaling \$226,050. Scholarship amounts ranged from \$500 to \$40,000.

Currently, the Foundation manages 77 scholarships. Scholarships may be endowed or funded annually. Criteria for awarding th scholarship are designed by the donors and the Foundation board of directors. Endowed scholarships are generated through the investment of permanently-held principals so that only the income from the principal is used for scholarship awards.




# **GOLF TOURNAMENT**
